- 5. Please submit the application form <u>at least 1 month</u> prior to the talk. Applications for talks scheduled in <u>upcoming 3 months since the date of submission</u> are welcomed.
- 6. Please return the confirmation form with signature and endorsement within 30 days after the date of issue, or otherwise will be regarded as cancellation of application.
- 7. The organiser is responsible for preparing ingredients or other materials required for the talks.



- 8. The minimum no. of participants per talk is 10. Application for deferral of talk is allowed just for once by prior written or email notice of not less than 14 days before the talk if the organiser is unable to run the talk as scheduled due to low enrollment rate or other reasons. Acceptance of deferral is subjected to availability. A 30% administration charge applies to request for cancellation of talk less than 14 days or second deferral of talk.
- 9. No refund is allowed on confirmed talk booked.
- 10. Arrangements in times of typhoons and inclement weather

### **Tropical Cyclones Arrangements**

- (a) Talks are to be suspended when Tropical Cyclone Warning Signal Pre-No. 8/No. 8 or above is issued.
- (b) Talks are to resume in general if Tropical Cyclone Warning Signal Pre-No. 8/No. 8 or above is replaced by Signal No. 3 or below not less than 3.5 hours before the talk commences. Contingency arrangements apply to individual organisers (e.g. Kindergartens/AM and Whole-day schools/schools for children with physical disability/schools for children with intellectual disability/elderly centres).\*

### **Heavy Persistent Rain Arrangements**

- (a) Talks are to be suspended when Black Rainstorm Warning is issued. Talks commenced may continue if conditions are safe. All participants are advised to take shelter at a safe place until the weather and traffic conditions have improved.
- (b) Talks are to resume in general if Black Rainstorm Warning is replaced by Red Rainstorm Warning not less than 3.5 hours before the talk commences. Contingency arrangements apply to individual organisers (e.g. Kindergartens/AM and Whole-day schools/schools for children with physical disability/schools for children with intellectual disability/elderly centres).\*
- \*Speakers and organisers should contact each other immediately after the aforesaid announcement had been made. Any contingency arrangements should take the abovementioned conditions as guiding principles.
- 11. The organiser is responsible for arranging basic equipment including but not limited to computer and projector for the talk. Speakers will process virus scanning of the USB/CD-ROM or any hardware for the talks.

- 13. Any audio recording, video shooting or photo-taking are prohibited during the talks. Written or email request should be made no later than 14 working days before the talks should it be necessary. UCN reserves the right to accept or reject the applications.
